To whomever it may concern,
EMQN is now operating independently from Manchester University NHS Foundation Trust (MFT), as a new legal entity called EMQN CIC. This means that EMQN now operates as a Community Interest Company (CIC). This is a legal model that obliges EMQN CIC to spend at least half of the profits on community benefit. This will enable them to continue to reinvest their profits into research and development, best practice, and training and education in genomics for the benefit of patients. The remainder can be spent on operational costs. There are no shareholders, so nobody personally profits out of EMQN doing well. This letter is to confirm that EMQN's transition to a fully independent company is underway. **EMQN CIC will be invoicing customers directly for the costs of participating in its 2019 EQA activities – this process will begin on Monday 21st October 2019** and your organisation's support to ensure that this proceeds smoothly is gratefully requested.

Manchester University NHS Foundation Trust will continue to work closely with EMQN to ensure a smooth transition to a fully independent EMQN CIC.
